NOTORIOUS PICTURES: AMBRA ANGIOLINI WINS THE "CINÉCIAK D'ORO" WITH THE PRODUCTION "LA VERITÀ, VI SPIEGO, SULL'AMORE"

Actress wins award for "Best Comic Actress" 2017

Notorious Pictures, a company listed on the AIM Italia market, organised and managed by Borsa Italiana (Italian stock exchange company), involved in the production, acquisition and marketing of film rights (full rights) via all the distribution channels (cinema, home video, TV, new media), announces that actress Ambra Angiolini has won the "CINÉCIAK D'ORO" award for the category of "Best Comic Actress" for her role as Dora in the sentimental comedy "La verità, vi spiego, sull'amore", the first production and distribution project entirely realised by the company.

"Ciné Ciak d'oro", now in its 6th edition, is the award conceived by CIAK magazine and presented to films and actors that have made their mark on Italian comedy, the nation's most popular film genre. Every year, the editorial office of CIAK awards prizes to the year's newcomers, divided into six categories, including Best comic actor and actress of the year, Ciné Ciak Classic and the Special Award Absolut Comedian. The awards ceremony took place at "Ciné-Giornate estive di Cinema" in Riccione, an event organised by Anica in partnership with Anec and Anem, and was conducted by Piera Detassis, editor of Ciak and President of Fondazione Cinema per Roma.

The film "La verità, vi spiego, sull'amore" deals with the problems of a 35-year-old woman in the face of her separation from her husband, and is based on the book by Enrica Tesio (Mondadori, 2015), inspired by the blog "Ti ASMO", a social phenomenon in 2013 which boasted over 150,000 views of one single post.

The comedy is directed by Max Croci, author of several SKY Italia productions and Nastro d'Argento winning short films. The cast also stars Carolina Crescentini, Massimo Poggio, Giuliana De Sio and Edoardo Pesce.
