# NOTORIOUS PICTURES APPOINTS BANCA FINNAT AS NEW NOMAD AND SPECIALIST AND GRANTS APPOINTMENT AS CORPORATE BROKER TO INTERMONTE

Notorious Pictures, a company listed on the AIM Italia market, organised and managed by Borsa Italiana (Italian stock exchange company), involved in the production, acquisition and marketing of film rights (full rights) via all the distribution channels (cinema, home video, tv, new media), discloses, pursuant to Article 17 of the AIM Italia Issuers' Regulation, that it has granted the appointment as Nominated Adviser and Specialist Operator to Banca Finnat S.p.A. as of today's date. At the same time, the company appointed IntermonTE SIM S.p.A. as corporate broker, an appointment which envisages, amongst other aspects, the launch of coverage by IntermonTE analysts of Notorious Pictures stock and the organisation of the activities with the institutional investors.

The appointments will be effective as from 17 November 2017.

Banca Finnat S.p.A. will take over from Banca Akros S.p.A. which will cover the role of Nominated Adviser and Specialist until 16 November 2017.
