NOTORIOUS PICTURES: AGREEMENT SIGNED FOR THE EXECUTIVE PRODUCTION OF THE FILM "ACROSS THE RIVER INTO THE TREES" FOR A VALUE OF EUR 5.1 MILLION

Milan, 18 July 2018

Notorious Pictures, company listed on the AIM Italia market, organised and managed by Borsa Italiana, active in the production, acquisition and marketing of film rights (full rights) through all the distribution channels (cinema, home video, tv, new media), signed an agreement with Spanish producer Milburn A.I.E. for the international executive production of the film "Across the river into the trees" as a result of which Notorious Pictures assumed the engagement of shooting the film in Venice, Italy, which will start by the summer.

Directed by Martin Campbell *(Casino Royale, Green Lantern, the Legend of Zorro),* the dramatic film boasts all-star international cast including: Pierce Brosnan, Maria Valverde, Giancarlo Giannini, Laura Morante, Matilde De Angelis.

The value of the job is EUR 5.133 million. Around 90% of the consideration for executive activities and shooting in Italy will be collected by Notorious Pictures in 2018. Executive production activities will benefit from the tax credit legislation that applies to the production of foreign films in Italy.

Guglielmo Marchetti, Company Chairman and CEO, stated:

"Thanks to this new agreement for the executive production of the dramatic film "Across the river into the trees", based on a novel by Ernest Hemingway, we'll strength the position of Notorious Pictures in film production also thanks to the recognition of major international players in the industry, the involvement in the project of an international cast with great artistic flair, with the contribution of one of the most important directors in the world like Martin Campbell who has directed major films".

Plot: US colonel Cantwell, scarred by events of WWII in which he fought and poor health, falls in love with a young woman from Venice. The relationship, dotted with moments of happiness and sad memories from the war, is threatened by the fact he doesn't have much time left, which marches on relentlessly.
