

NOTORIOUS PICTURES: agreement with TaTaTu, the social entertainment platform, for Avod license for 300 films

Notorious Pictures, a company listed on the AIM Italia market, organised and managed by Borsa Italiana, active in the production, acquisition and marketing of film rights (full rights) through all the distribution channels (cinema, home video, TV, new media), has announced it has signed a two-year agreement with TaTaTu, the innovative Avod (advertising video on demand) social entertainment platform which represents the third largest operator in the world based on blockchain, for the licensing of 300 films. For Notorious, compensation will take the form of revenue sharing.

TaTaTu is a revolutionary solution based on blockchains and marked by a revenue sharing mechanism in which advertising revenues are shared amongst content providers and users. It is an entertainment social network in which celebrities and members can monetise their social media activities. TaTaTu's goal is to become the universal token in the entertainment industry with 600 million users by 2021. The TaTaTu token is the first in the entertainment industry and will represent the electronic means for supporting film production through transactions between users, content owners and brands. Through Digital Rights Management ("DRM") TaTaTu makes it possible to manage licensing rights between users, type of content and jurisdiction all over the world and in a fully transparent and efficient manner.
