NOTORIOUS PICTURES: AGREEMENT WITH MEDIASET FOR FREE TV RIGHTS FOR A FILMS SELECTION

The Library titles granted include: "Bridge to Therabithia", "Planet 51" and "The Cold Light of Day"

Notorious Pictures, a company listed on the AIM Italia market, organised and managed by Borsa Italiana (Italian stock exchange company), involved in the entertainment sector through the production, acquisition and marketing of film rights (full rights) via all distribution channels (cinema, home video, TV, new media), and the management of cinemas through its subsidiary Notorious Cinemas, has signed a trade agreement with Mediaset RTI SpA for exclusive Free TV rights for the distribution of a films selection.

The film rights contract is worth 0.8 million Euro. The titles in the Notorious Pictures library set to be broadcast include: "Bridge to Therabithia", "Planet 51" and "The Cold Light of Day".

Guglielmo Marchetti, Chairman and Chief Executive Officer of Notorious Pictures and Chairman of Notorious Cinemas, made the following comment: "*With this new agreement, the partnership between Notorious Pictures and Mediaset RTI continues, as one of the leading operators in the Free TV scene, and the company's positioning in television distribution is further strengthened. The agreement confirms the value of our library, marked by high quality artistic and commercially appealing titles".*
