

# NOTORIOUS PICTURES: INTERNATIONAL CO-PRODUCTION OF THE COMEDY "LOVE, WEDDING, REPEAT" UNDERWAY

"Love, Wedding, Repeat" is a comedy halfway between "Sliding Doors" and "Four Weddings and a Funeral", set in the outskirts of Rome, more specifically in Villa Parisi in Frascati, one of the twelve Ville Tuscolane. The film tells the story of some British and American guests at a wedding in Rome and how an apparently insignificant detail such as where they are made to sit at a wedding, at one table rather than another, can have a huge and definitive impact on their destinies in life. The film is directed by Dean Craig, the screenwriter of Death at a Funeral and A Few Best Men; this is his directing debut after working alongside directors such as Frank Oz, Neil Labute, Stephan Elliott and Marc Forster.

The cast includes: Sam Claflin (Hunger Games Saga, Me Before You, Adrift), Oliva Munn (X-Men: Apocalypse, Ocean's 8, Office Christmas Party) and Freida Pinto (Slumdog Millionaire, Rise of the Planet of the Apes).

The company's President and CEO **Guglielmo Marchetti** said: "Our international co-production successfully continues: we have begun shooting the film with an international cast in Rome, in one of the most beautiful locations in Italy. We are pleased to have Tempo Productions as a partner in this strategic collaboration based on a shared cinematic and commercial vision."
